  - A. Not in attendance: Graduate Senator Danny Partida, Veteran Representative Tony Oschner

- IV. New Business
  - A. T-Bird Bikes Funding Refer to SUUSA S.B. 006 Bill: Support and Funding for T-Bird Bikes CAST Sen. Cox: T-Bird bikes seeks to receive a \$5,000 grants from the Southwest Utah Public Health Department
    - 1. International Rep. Paz: How will the bike safety portion of the bill be enacted? VP of Finance Sutton: They would be taught when to yield to vehicles, the signals, how to pick a proper helmet, etc. Unsure of if there will be teaching portion of how to ride a bike, bit the people working for T-bird Bikes are very helpful and would probably be willing to teach someone how to ruide one
    - 2. Business Sen. Matheson: WHat measures are there that ensure the students who rent the bikes will take good care of them? Sutton: If a student brings in a bike that is broken, they would lose the privilege of renting the bikes again. VP of Clubs Colby: There is probably a sort of deposit before using a bike.
    - 3. Greek Rep Moore: What would the process of renting the bike be? Sutton: It is more on a long-term basis so a student can use it to commute to and from classes all semester. Chief of Staff Stewart: The concept is for students to rent it for the time that they'll need it for. It may be just for a trip to the store or for an entire semester to commute to classes.
    - 4. Rep. Paz: Are there any ideas of adding any bike racks around campus to promote more people using bikes? Sutton: Part of this bill will evaluate the bike accessibility on campus. They will assess the issues, if any, of where to park a bike on campus.

In the INFO 1010 class, it is taught in both MLA and APA format, so students get that opportunity within that class.
- C. Plan B Refer to Plan B: Student Health and Wellness Center Handout CDI Rep. Hawk: Proposing for Plan B to be offered and regulated by the Health and Wellness Center. The money required would not come out of SUUSA budgets. The Health and Wellness Center would receive the money from a grant. Administration would just need to approve the distribution of Plan B, everything else would be handled by the Health and Wellness Center.
