ADMINISTRATION	
<i>G. Michael Stathis, Director (GC 406N)</i>	
<p>The Department of Political Science and Criminal Justice administers an interdisciplinary academic program in international relations which can serve as the basis for a specialized study of political science, or for a study of international relations by students with majors in other departments. The purpose of the certificate is to increase academic interest in the study of international affairs and to offer students valuable certification for future applications for graduate study or professional careers.</p> <p>The program requires the successful completion of eight courses, six of which must be chosen from the political science curriculum. Certification is conferred upon graduation with a Bachelors degree.</p>	
Requirements	
<ol style="list-style-type: none"> 1. Students must submit a program of study with the department or the program director at least two semesters prior to graduation. 2. Students must complete eight courses from the list established for the certificate program. At least six of these courses must be political science courses including two core courses: POLS 2100 Introduction to International Relations, and POLS 4600 Theories of International Relations. 3. All requests for course substitutions must obtain prior approval from the program director. 4. Students must complete their courses with an overall 3.0 grade point average in the program. 5. Students must submit, to the program director, the Final Approval Form which lists courses taken for the certificate along with a current transcript the semester before they intend to graduate. 6. All courses must be completed with at least a "C". 7. The Certificate of International Relations is granted to students who meet Southern Utah University's requirements for graduation with a Bachelors degree. 	

Certificate of Public Administration	
Advising and Admission	
<i>Professor Carl Franklin, Director (GC 406)</i>	
<p>The department is authorized to grant an Undergraduate Certificate in Public Administration (UCPA). Students should consult a faculty member in the Public Administration area for advisement.</p> <p>The undergraduate certificate is an interdisciplinary approach in several related areas that is designed to assist students to be considered for entry-level administrative positions in government.</p> <p>Admission requirements include graduation from an accredited high school with at least a 2.89 GPA or completion of 20 credit hours of college or university work with a GPA of at least 2.5; regular enrollment as an undergraduate student; and a letter of intent from the prospective student.</p> <p>When admitted, the student meets with the program director to develop a program outline. The program director advises students throughout their programs.</p>	
Requirements	
<p>The student must complete the program's course requirements and the bachelor's degree. Total program units required vary between 27 and 30 credits, depending on courses taken. The student is expected to maintain a GPA of at least 2.5 throughout the program and receive no less than a grade of C- in any course. Many program courses also fill major and/or minor requirements. The Public Administration Undergraduate Certificate Program consists of two parts – Required Courses and Functional Specialization – as shown below.</p>

Students Interested in Attending Law School

Although Southern Utah University does not have a formal Pre-Law program, we have an excellent track record of placing students in some of the finest law schools in the United States. Associate Professor Carl Franklin in GC 406L should be contacted for guidance during the student's undergraduate education.

Typically, students entering law school are Political Science majors. However, Criminal Justice majors also do well in law careers.

Notable law schools consider the student's overall GPA in addition to each student's LSAT (Law School Admissions Test) score when considering granting admission. Good grades throughout one's undergraduate career are essential.
