Assistant Professor, Southern Utah University

August 2008 to Present

I teach various criminal justice courses including Criminology, Rules of Evidence, the History of Criminal Justice, Terrorism, Criminal Procedure, Criminal Justice Seminar, Special Topics and Administrative Law. I am the CJ Honor Society advisor. I am on the University Curriculum Committee, Department LRT Committee, Chair of the CJ Search Committee in 2009, and an editorial board member of the Department journal, *Critical Issues in Politics and Criminal Justice*. I am co-chairman of the Department's first international study abroad program. I have initiated a program which brings French law students to SUU to study during the summer. Developed with Professor Perry a study abroad program for the department and took 10 students to Europe to study. From June 1 to August 26, I was a visiting professional at the International Criminal Court in The Hague, Netherlands. In 2010, I am the editor of the *Critical Issues in Politics and Criminal Justice*, Chairman of the CJ Search Committee and Chairman of the LRT Committee.

Associate Professor, Bethany College

August 2005 to August 2008

I served Chairman of the Criminal Justice Department. The classes I taught included Criminal Law, Substance Abuse, Criminal Procedure, Police and Society, Judicial Process, White Collar Crime, Ethics, Terrorism Homeland Security and America's Courts, Bethany Seminar and the Senior Seminar. I was elected by the faculty to the Faculty Policies Committee, to the Curriculum Committee and to the Faculty Senate. I was appointed by the President to the SEM Marketing Committee. I served as the co-chair of the Inaugural Committee for the inauguration of Ed Leonard. In March of 2006, I presented a paper entitled "Learning Disabilities and Attention Deficit Disorder: A New Approach for the Criminal Justice System" to the Oxford Round Table at Oxford University. Judge, King County District Court

January 1983 to July 2005

In 1982 at the age of 33, I was elected District Court Judge and was the youngest judge in the State of Washington. I was reelected every four years without opposition. During my tenure on the bench, I heard and decided literally thousands of criminal and civil cases. I resolved constitutional questions, determined disputed facts and sentenced and supervised those convicted of criminal offenses. I worked with the mentally ill, alcohol and drug addicted offenders, domestic violence offenders and victims and indigent individuals.

Lifeskills Program: In 1989, I established a new and innovative program for the learning disabled and /or ADD offender. In this program, offenders are screened and evaluated to determine if they suffer from learning disabilities or ADD. There is a 40% reduction in the rate of recidivism for those completing this program. This program was singled out as the only effective program in dealing with this population and has been instituted in several states.

DWI Victims Panel: In 1984, I established the first program in the United States where convicted DUI/DWI offenders are required to sit and listen to a panel of victims of drunk drivers describe how they were affected by the drinking driver. This program has been copied and is now in place in over forty states. In many states, this program has been adopted and required by statute.

Training: At the request of the Washington State Supreme Court, I have on several occasions provided training to Washington State judges in alternative sentencing methods, alcoholism, drug addiction, learning disabilities and attention deficit disorder. I have provided similar training to judges from around the United States at the request of a national judicial conference.

Adjunct Professor, Seattle University

September 1977 to September 1997

I taught Criminal Law, Criminal Procedure in the Criminal Justice Department. At the request of the Department Chairman, I also developed and taught a new course, The Criminal Trial in Perspective. These classes were taught in the evening. I also provided the opportunity to numerous students to study with me through an internship in the King County District Court.

Redmond City Council**January 1980 to January 1983**

At the age of 30, I was elected to the Redmond City Council. As a member of the City Council, I set public policy for the City of Redmond in all facets of local government including budget, strategic planning, public safety, environmental protection and growth management. In this position, I had to work cooperatively with a diverse group of business, public and professional organizations and individuals to assure that all parties' concerns were heard and considered during the legislative process

Practice of law**August 1974 to December 1982**

During this period of time, I was engaged in a general civil and criminal trial practice as a partner and associate in a law firm. I also served as a criminal prosecutor for the City of Seattle. Upon graduating from law school, I was hired as the Director of a rural legal aid office. At that time, I supervised one attorney and a staff of six in the representation of indigent individuals in both criminal and civil matters.

U. S. Senator Henry M. Jackson**June 1971 to May 1974**

As an assistant to Senator Jackson in Washington, D.C., my responsibilities included advising the senator on federal legislation and state issues involving various government agencies and departments including agriculture, transportation, and airline regulation and safety.

Upon successful completion of this course of study, the student may sit for the bar exam and if successful is admitted to the bar as an attorney. My clerk passed the bar exam and is now practicing law.

I have established an internship program for French law students from Cergy Pontoise University near Paris. These students come to my court to study with me and observe the US judicial system. I have a standing invitation to lecture at Cergy Pontoise and attempts are being made to use video conferencing so that I can lecture from Redmond.
