
INTERNATIONAL STUDENT FINANCIAL STATEMENT FORM

This form is not an application for financial assistance. The U.S. Bureau of Citizenship and Immigration Services requires an international student to show that funds are available for the first year of study, and that adequate funding will also be available for subsequent years.

The official letter from a banking institution showing the amount of funds available must accompany this form. This must be in U.S. dollars.

SPONSOR'S STATEMENT

- Students who are being sponsored by their family or other individuals or agencies must have their sponsor submit a statement that the sponsor will assume financial responsibility for the student's first year expenses and that the funds are available to the student for each academic year. This must be in U.S. dollars.
- Financial statements become the property of Southern Utah University and cannot be returned to the student.
- If a student needs a new I-20 Certificate of Eligibility for any reason, and the financial statement on file is over a year old, a new financial statement will be required.
