

UNIVERSITY CURRICULUM COMMITTEE MEETING

CN 207, 7:00 a.m.

December 1, 2004

MINUTES

Present: Rod Decker, Dianne Werber, Maxine Stolk, Vic Brown, Richard Tebbs, Terry Alger, Kirk Fitzpatrick, Judy Higbee, Tony Pellegrini, John Groesbeck, and Shauna Mendini. Others: Rick Lampson, Ann Smith, and Brian Heuett.

Rod stated that all changes in curriculum presented from last meeting were accepted by the Dean's Council.

College of Education Judy Higbee presented Outdoor Recreation, Parks and Tourism as a new degree program in education. The course prefix will be ORPT. A one-half FTE has already been identified to teach the course and another 1.5 FTE is being considered.

Discussion followed concerning student enrollment, staffing, and the impact on other programs offered on campus. Following discussion Terry Alger moved to approve the program. The vote was unanimous.

Judy presented a new one hour course needed in elementary and secondary education. The course prefix and title would be SCED 2010-Teaching Process Lab and ELED 2010 – Teaching Process Lab. The course will address issues that students must understand to navigate programs admissions, assessment, and licensure procedures. Terry Alger seconded the motion and it passed unanimously.

Judy presented new courses for a new program in physical education, Exercise Science; seconded by John Groesbeck. This program is designed for students who are interested in this type of program as they progress on to graduate school. Courses presented: PE 4010; PE 4020; PE 4030, and PE 4040. Discussion followed and it passed unanimously.

Judy presented DANC 3860 course to be dropped because it is no longer being taught. Judy presented class replacement courses of DANC 1020 or DANC 1550; seconded by Shauna Mendini. The vote was unanimous.

Judy presented new course PE 2000 – Wellness Dynamics. This course was approved as an interdisciplinary course in GE; seconded by Shauna Mendini. The voting was unanimous.

Student Success Brian Heuett presented UNIV 1000- Student Success. This course has been approved by the GE subcommittee. Students will be required to attend four Convocations per semester. Discussion followed concerning the number of credit hours (1) for the course. Terry Alger motioned for approval; seconded by Shauna Mendini and the voting was unanimous.

College of Science Terry Alger presented courses CHEM 1120, 1220, 3160, 3220, 3610, 3620, 3630, 3700, 4160, and 4230 to include prerequisites of a grade of 'C' or better on order to move to the next course level. The motion was seconded by John Groesbeck and the voting was unanimous.

Terry presented course changes for state articulation requirements, NFS 2200 change to NFS 1240 and NFS 2210 change to NFS 1241. John Goresbeck seconded the motion and it passed unanimously.

Terry presented nursing program courses for credit hour reduction NURS 4550 (8) hours to (7) hours; also NURS 1010, degree requirement for BSN degree to NURS 1010 as an elective course. New courses presented were NURS 3125 and NURS 3145. These courses are designed for nurses who are returning to obtain their RN degrees. These courses will be taught only during the summer. There was no further discussion. Shauna Mendini seconded the motion and it passed unanimously.

Terry presented courses in Physics that will be moved to fall or spring semesters. It was felt by the UCC that no action needed to be taken. These changes can be made through the department.

Terry presented changes to PHSC-1020 to PHYS-1015; PHSC 3310 to PHYS 3310; and PHSC 3320 to PHYS 3320 to comply with prefix changes for state articulation requirements. Motion seconded by John Groesbeck and the vote passed unanimously.

Terry presented course changes CHEM 3630 to CHEM 3615; CHEM 3640 to CHEM 3625; CHEM 4170 to CHEM 4165; also change in GEOG 3560 to GEOG 3555; and Geology course prefix from GEOL to GEO to comply with state articulation requirements. The motion was seconded by Shauna Mendini and it passed unanimously.

College of Integrated Engineering and Technology Richard Tebbs presented course deletion for ENGR 1020 and prerequisite change for ENGR 3045. Richard presented new course, CM 2000 – Statics for Construction Management because students in construction management do not need materials contained in ENGR 2010. Judy Higbee seconded the motion and it passed unanimously.

Richard presented course deletions in IS 4600 and CS 4720 due to courses being revised in CSIS curriculum. There was no discussion; John Groesbeck seconded the motion and it passed unanimously.

Richard presented prefix changes in EET (Electronics and Engineering Technology) to ECET (Electronics and Computer Engineering Technology). Overall program changes will include CS will have 3 ECET courses in the core and 1 ECET elective; IS will have 2 ECET courses in the core and 2 ECET electives; ECET will require 5 CS/IS in the core; and CAD/CAM will have 1 ECET core requirement. John Groesbeck seconded the motion and it passed unanimously.

College of Humanities and Social Sciences Kirk Fitzpatrick presented new courses in history; HIST 1500 and HIST 1510. Courses will be accepted as regular courses but they will have to go before the GE subcommittee for GE approval. HIST 1010 changed to HIST 1100 and HIST 1020 changed to HIST 1110 for state articulation requirements. There was no discussion; Richard Tebbs seconded the motion and it passed unanimously.

Kirk presented ENGL 2250- Literature and Film which was previously presented and sent back for revisions. Following discussion it was moved by Terry Alger to accept the course as a regular course. This course will need GE subcommittee approval. The voting was unanimous.

Kirk presented SPAN 4510 with prerequisite changes to include SPAN 3210 and 3212, grammar classes needed before student can take SPAN 4510. The motion was seconded by Judy Higbee. There was not discussion and the voting was unanimous.

School of Business John Groesbeck presented title change for ECON 2010; seconded by Richard Tebbs. There was no discussion and the voting was unanimous.

John presented Marketing Major changes from the requirement of 24 hours to 21 hours and require only three courses in the core--Consumer Behavior, Marketing Research and the capstone course Marketing Management. Students will then choose four more courses, three in marketing and one course outside the School of Business. The motion was seconded by Kirk Fitzpatrick and the vote was unanimous.

John presented Management minor change to require ACCT 2010 instead of ACT 2020. The motion was seconded by Richard Tebbs and the vote was unanimous.

John presented changes in curriculum for Finance. Changes include required course FIN 3770 and change FIN 4760 to an elective. Removed FIN 4450 and ECON 4500 from the list of electives and students can choose three electives FIN 4760, FIN 3110, ECON 3020, ECON 3840 and ECON 4260; MGMT 3210-Entrepreneurship will be offered fall semester only. Richard Tebbs seconded the motion and it passed unanimously.

John presented FIN 3000 as a new course in Hotel Resort Management. This item was tabled until the next UCC meeting.

College of Performing and Visual Arts Shauna presented ART 4210-Branding from last meeting where the name of the course was questioned. The course name will remain 'Branding'. Shauna presented ART 3750-History of Graphic Design, prefix change to ARTH 2750-History of Graphic Design/ TA 3131-Professional Aspects of Theatre one credit to TA 3110, 3120, and 3131-Professional Aspects of Theatre (1, 2, or 3 credits). John Groesbeck seconded the motion and it passed unanimously.

Shauna presented AA 3010 – Survey of Arts Administration as an additional requirement for Management and Education focus within Theatre. This item was tabled until next meeting. More paper work is required.
