

## FAA TESTING IDENTIFICATION VERIFICATION

The following information is provided to help you with FAA examinations.

FAA exams are administered in the SUU Specialized Testing Center (ELC, Room 211).

To schedule and pay for an exam contact PSI/CATS at **(844) 704-1487**.

- FAA tests can be scheduled immediately by PSI/CATS (only) for testing on Tues, Wed, or Thurs from 10:00 am - 1:00 pm and 1:30 pm - 5:00 pm.
- For testing on Mondays or Fridays (same times), appointments must be confirmed with both CATS and SUU Specialized Testing in advance (as other types of tests are often administered on these days). Please plan ahead accordingly. The phone number of SUU Specialized Testing for Mon or Fri testing is 435-865-8113.

All students taking FAA Airman Knowledge Tests must bring **current** and **valid** identification. Identification must include the following:

- Photo
- Date of birth
- Signature
- Current physical, residential address (not a PO Box)

The most common forms of identification include:

- Driver's License
- U.S. Military Identification Card
- Passport
- Alien Residency Card

Non-U.S. citizens need a passport AND a driver's license/identification card.

The above identification may be presented in more than one form.

If the acceptable form(s) of identification (as listed above) does not include **valid** and **current** proof of the applicant's physical/residential address, the applicant may utilize his or her parent's permanent, physical/residential address; or the applicant may provide proof by presenting one of the acceptable forms of applicant address verification listed below.

- FAA Form 8060-4, Temporary Airman Certificate
- FAA Form 8420-2, Medical Certificate – Class and Student Pilot Certificate
- FAA Form 8500-9, Medical Certificate \_\_\_\_\_ Class
- FAA Form 8610-1, Mechanic's Application for Inspection Authorization
- FAA Form 8610-2, Airman Certificate and/or Rating Application
- FAA Form 8710-1, Airman Certificate and/or Rating Application
- FAA Form 8710-2, Student Pilot Certificate
- DD Form 93, Record of Emergency Data
- DD Form 2058, State of Legal Residence Certificate

- Form DS-2019, Certificate of Eligibility for Exchange Visitor (J-1) Status
  - (aka, Department of State / Department of Homeland Security “Student and Exchange Visitor Information System (SEVIS) eligibility printout”)
- Public utilities (i.e., water, electric, gas) statement
  - Statements from cable companies are NOT an acceptable form of applicant address verification.
- Mortgage statement
- Lease agreement (signed)
- Property deed
- Property tax bill or receipt
- Homeowners or renters insurance statement
- Motor vehicle title/registration documentation
- U.S. Military ‘Home of Record’ documentation
- Voter registration card
