MAcc 25th Anniversary

This summer, it will be twenty-five years since the Utah State Legislature gave authority for SUU to offer a Masters of Accountancy (MAcc) degree, which was the first stand-alone graduate degree offered on campus. In the years prior to the Legislature's granting of authority, CPA societies throughout the nation had been advocating for all individuals to have 150 hours of education prior to their being eligible to become a CPA.

Utah was the fourth state to adopt that provision, and is the reason why SUU received authority to offer a MAcc degree. Under the direction of Professor Gary Giles, a curriculum was created and in the summer of 1985, the SUU Accounting Department hired three professors to teach the curriculum. Those three professors were: Tim Lewis JD, David Rees Ph.D., and Scott Clark MAcc. Professors Lewis and Rees are still at SUU, teaching accounting and business law courses. Professor Giles, after a lengthy term of service to SUU and

the Accounting Program, retired and was honored by having his picture in the Hunter Conference Center.

This Fall in conjunction with Home Coming, a 25th Anniversary Celebration is being planned and all MAcc alumni are being invited to return to campus and participate in the Celebration. A Committee of over 40 MAcc alumni has been formed to stay in contact with alumni and plan the celebration. In the twenty-five years since its inception, SUU's MAcc program has evolved into a premier accounting program in the West, with its graduates widely sought by CPA firms. Recently, Piercy, Bowler, Taylor and Kern, a regional CPA firm, gave a gift



of money to be used for scholarships and to bring state-of-the-art audio/visual facilities to a classroom named in their honor. Other CPA firms are considering doing the same. This is a tribute to the dedication of all accounting professors over the years and—even more so—to the hard work and contribution to their company's success that the MAcc alumni brought.

Finally, this Celebration of the 25th Anniversary of the MAcc Program is intended to be as much a tribute to the future of the program as it is a celebration of the accomplishments





Business Students Take Top Honors

Southern Utah University's Delta Epsilon Chi Club (DEX) collected nine awards at the State Delta Epsilon Chi Career Development Event where students competed in a variety of events to test their knowledge in sales, marketing, retail management, advertising and finance.

The events included taking written tests and preparing individual presentations in 30 minutes to solve industry specific problems. These competitions are designed to help students apply the information they have been learning in class in more realistic settings where deadlines and quick thinking factor into the decision-making process.

“It really puts our overall business knowledge to the test while we work to solve real world problems,” said first-place winner Beth Bosshardt, a senior business management major at who was recognized with an individual first place finish in the Restaurant and Food Service competition as well as with the top team finish in the International Marketing group along with her partner Nate Holt, a senior management major at SUU.



Other SUU DEX students who earned first place recognition include senior marketing management major Megan Campbell for her performance in Fashion Merchandising; junior finance major Kim Smedley for her performance in Travel and Tourism Merchandising; and Jennifer Hunter for Human Resources.

Other award winners from SUU included: Lisa Iler, a marketing major who earned her SUU degree in December of 2009; senior marketing major Desirae Holdaway; and junior biology major Jade Askeroth.

Students will continue to refine their presentation skills as they prepare to travel to the national DEX competition April 17-20 in Louisville, Kentucky.

The DEX program engages students from a variety of educational disciplines, while maintaining a strong focus on business-related areas such as marketing, management and entrepreneurship.

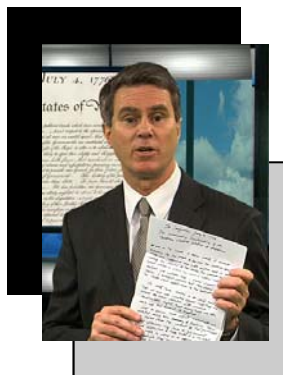
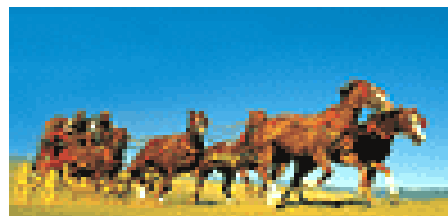
Public Accountancy Club

He has also published research on family labor supply models and post-secondary pedagogy in economics. In 2006-07, he was a Fellow of the American Council on Education (ACE).

HRHM Site Visits & Career Opportunities

During the Fall 2009 Semester, the Hotel, Resort, and Hospitality Management (HRHM) professors and students continued their experiential learning visits to industry leaders. With a focus on hotel design, hotel operations, and career development, they went to Las Vegas to take tours and hear presentations at the Encore, Mandalay Bay, and Venetian. Karina Ashworth, VP of Design, and some of her staff, conducted the tour at Encore. Renee West, President and COO of Mandalay Bay, along with two vice presidents, Rick Fields and Brian Robison, spoke to students about hospitality careers, and about the importance of having a hospitality degree. They then took students on a fascinating tour of operations. SUU students subsequently toured and heard presentations at the Venetian and Palazzo. Paul Dungo arranged for and conducted the tour. He previously had worked with Professor Assante at the Venetian.

On October 28th SUU Hospitality Management students took a trip to Salt Lake City and visited the Grand America Hotel, the only Five Diamond hotel in Salt Lake City. The trip emphasis was on facilities management and lodging design, so the students saw HVAC, laundry, and water systems, along with guest rooms, public space, and meeting rooms. Clayton Roop, Director of Engineering, and Anthony Bartholomew, Director of Operations, conducted the tours, and subsequently invited students to lunch at the Garden Café buffet. The students then proceeded to Control 4, where Paul Williams, VP Support Services, treated students to a fascinating hotel guest room technology presentation. Draperies, TVs, door locks, wake-up calls, lights, and more, can be managed by remote control.

2010 Volunteer Income Tax Assistance Program (VITA)

The Volunteer Income Tax Assistance (VITA) program is a community outreach program established by the IRS. The purpose of the program is to assist low-income families in the local community by preparing federal and state income tax returns for said community members without charge. The program is administered by IRS authorized sites through volunteers who are certified by the IRS for tax return preparation. The School of Business Accounting Department is an IRS authorized site which has been administering the VITA program since January of 2000. Currently, Asst. Prof. Robin Boneck serves as advisor and Assoc. Prof. Jeff Barnes serves as co-advisor to the program.

The Accounting program provides this service to our local community as a service-learning component in Accounting 3200 (Individual Income Tax) and Accounting 4200 (Tax Research). The students in each of these tax classes are required to become VITA certified and prepare tax returns for low-income families in our local community. Their service gives them hands on tax preparation experience, enhancing their tax education, and provides them an opportunity to serve the community. Each year a Masters of Accounting student serves as the manager of the VITA site and enlists the assistance of several other students to provide daily supervision of accounting students (undergraduate and graduate) who provide the daily volunteer service to our local community.

The VITA program was incredibly successful this year. Derek Anderson, along with assistance from several other accounting students serving as supervisors (Christen Meyer, Jake Pickett, Erik McCarthy, Jeremy Seymour, Josh Gertsch, Tynette Spafford, and Amy Hancock) managed the program. 730 tax returns were filed and accepted by the IRS this year. 51 accounting students volunteered to prepare tax returns for qualifying taxpayers residing in the Cedar City area. Over 800 hours of volunteer service were provided by students from late January until April 8th. All tax returns were prepared and filed at no cost to the taxpayer. We estimate that providing this service saved the citizens in our community approximately \$146,000 in tax preparation fees. Most impressive is the fact that the community received approximately \$1,270,000 in income tax refunds through our service which exceeds last year refunds by \$137,000.
