To apply for Summer 2016 financial aid, you must:

- ☐ Complete and submit a FAFSA for the 2015-2016 year, if you have not already done so.
- ☐ Complete your financial aid file by submitting all documents we have requested.
- ☐ Complete and submit this SUU Summer FA Application.
- ☐ Register at least half-time (summer half-time hours are: undergraduates 6 hrs. graduates 5 hrs.)
- ☐ Meet Satisfactory Academic Progress (SAP) standards to qualify for financial aid. SAP is checked after final grades are posted at the end of each semester.

Summer Financial Aid funds are subject to your eligibility and may include: Federal Pell Grant, Direct Loans, Parent PLUS Loans, and Alternative Loans. In general, you must maintain at least half time enrollment to receive federal aid. The only exception is that in some cases, students who are eligible for Pell in the summer may receive Pell if they are enrolled less than half-time. If eligible students are enrolled less than full-time, Pell will be prorated to 25% for less than half-time, 50% for half-time or 75% for three-quarter time enrollment. If your enrollment changes during the summer, your Pell may be adjusted or your Loans may be canceled.

Note: Students who received Pell as a full-time student in both the Fall and the Spring, will not have remaining eligibility for a summer Pell.

Summer loans will not disburse to your account until you are attending at least half-time. For example, if you are in 3 hours for the Maymester and 3 hours 1st session, your loans will not pay until the 1st session begins.

Note: If you will change grade levels after the Spring 2016 semester, your yearly loan limit may increase. However, an increase for your summer loan award cannot be considered until after Spring grades have posted. You may notify our office once your grade level has been updated to see if you are eligible for additional funds.

SIGNATURE AND STATEMENT OF CERTIFICATION

- ☐ I understand that I must be enrolled at least half-time to receive loan funds in the summer.
- ☐ I understand that my loans will not disburse to my account until I am attending classes at least half-time.
- ☐ I understand that Direct student loans are subject to yearly loan limits. If I have borrowed the maximum loan amount for my grade level during the fall/spring, I will not be eligible for any summer Direct loans.
- ☐ I understand that I must continue to make Satisfactory Academic Progress in order to receive summer financial aid.
