

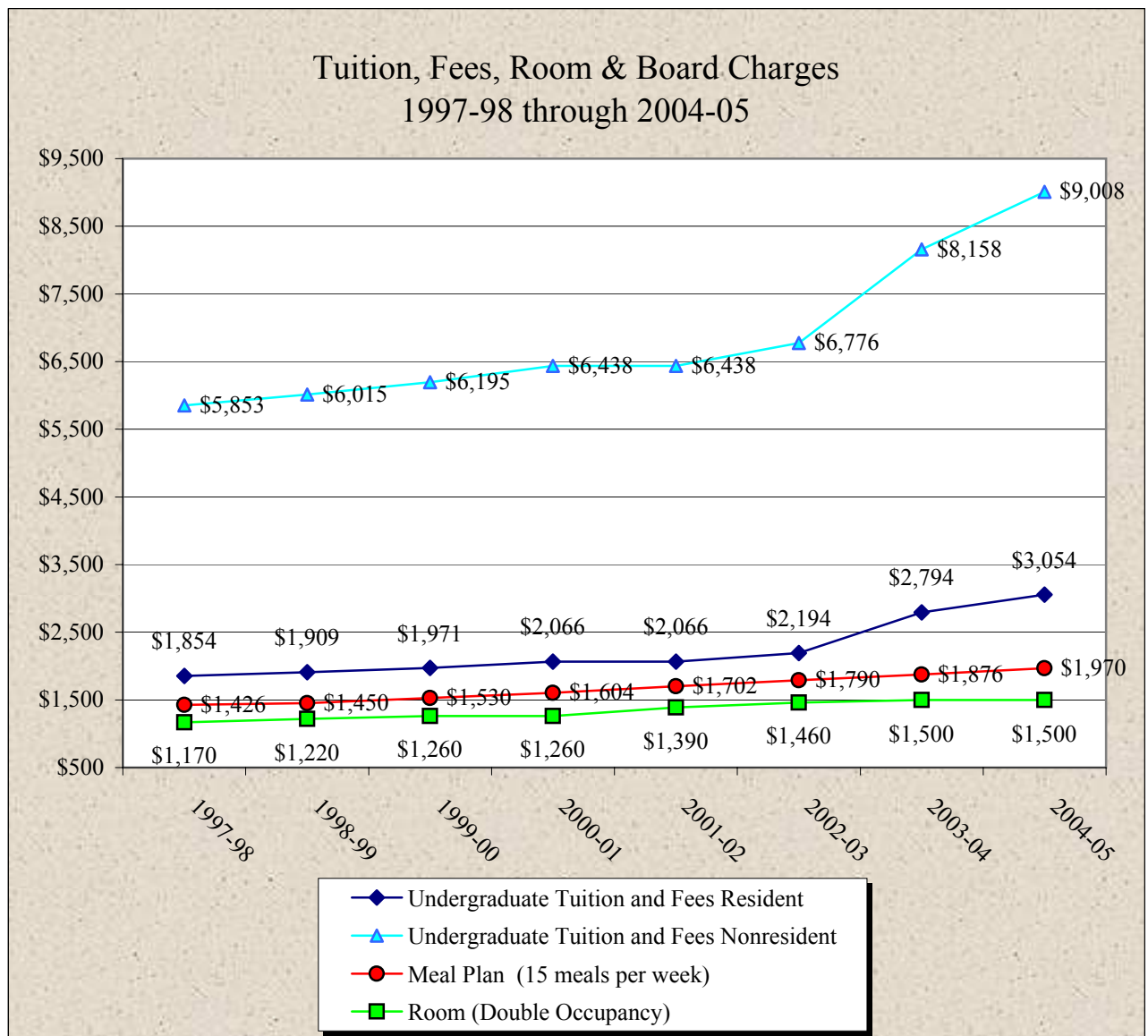

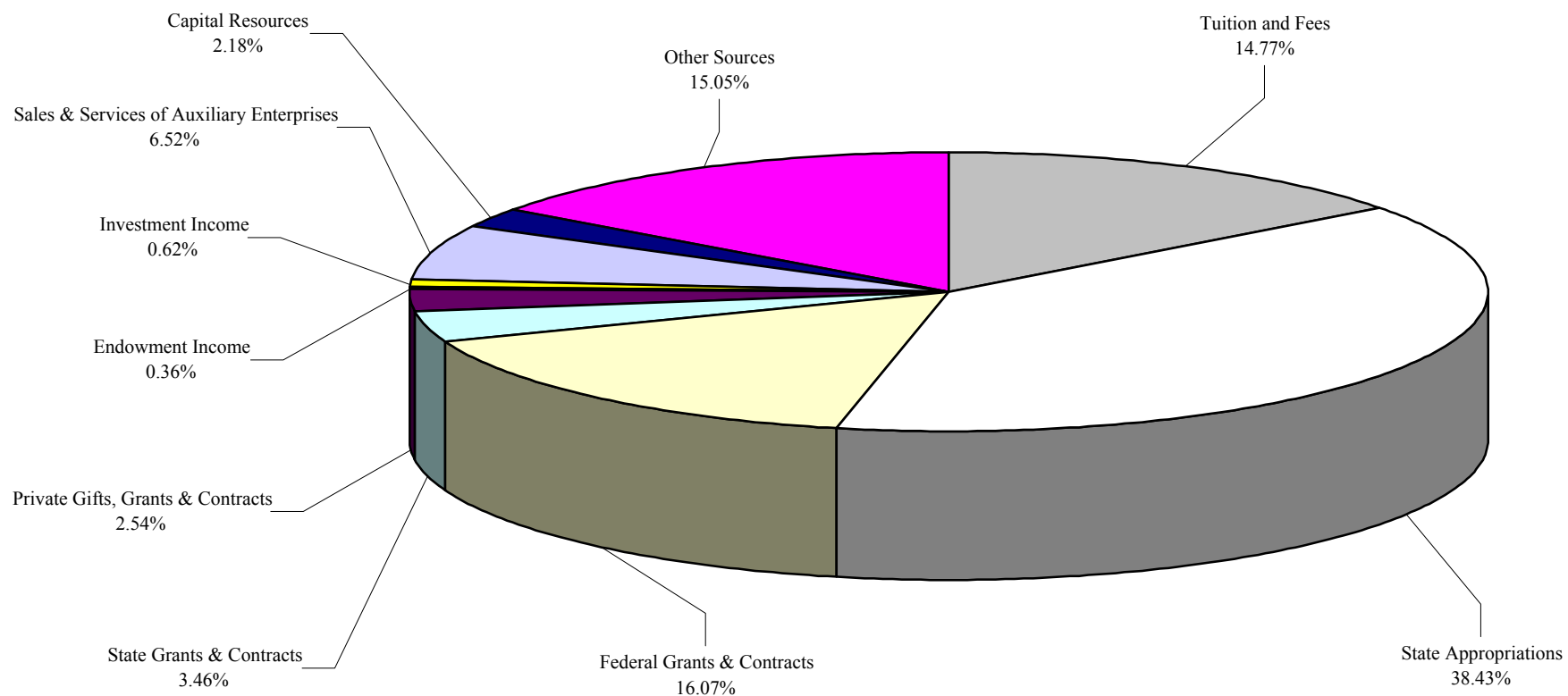

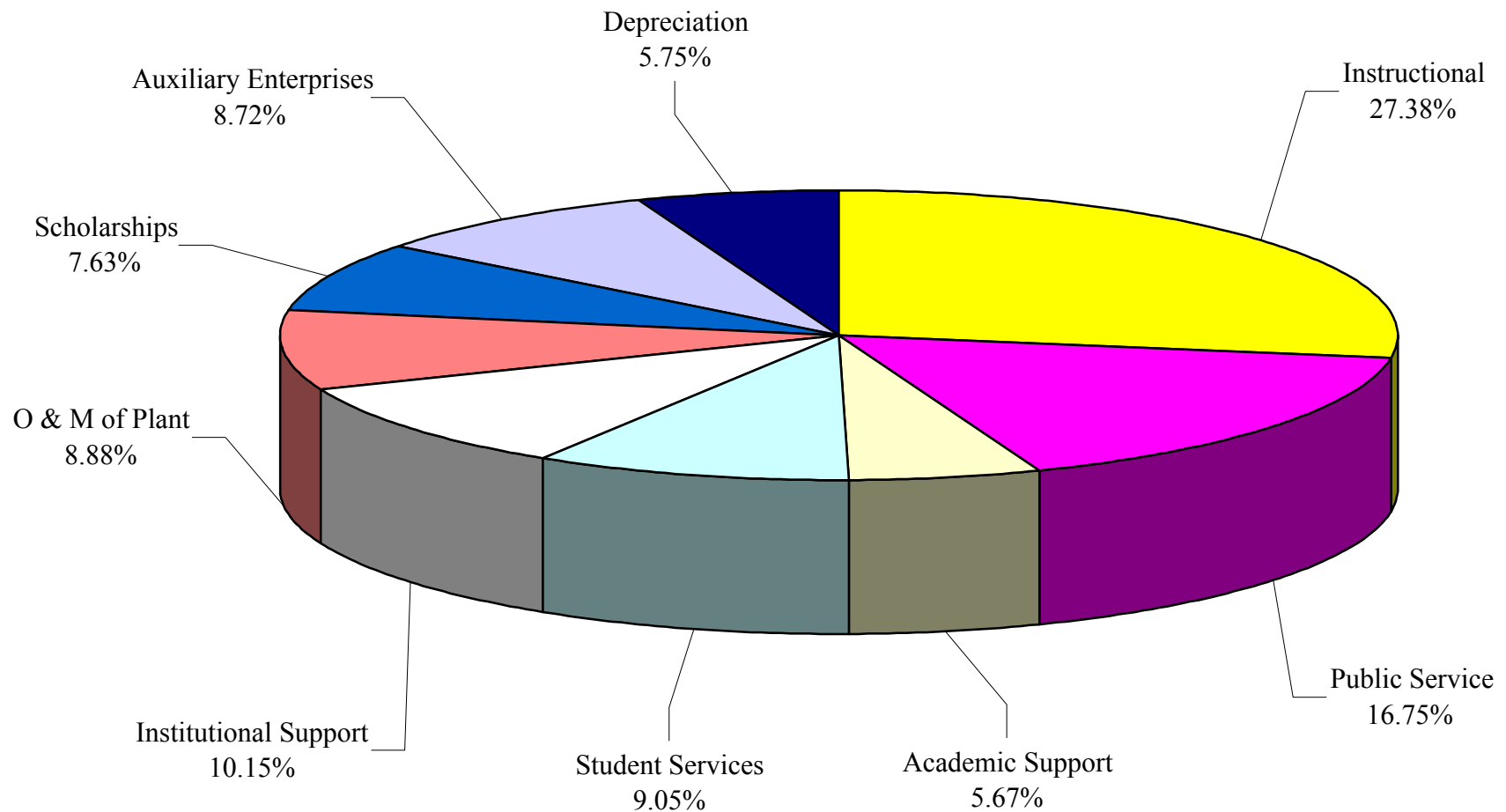
Summary of Current Fund Operating Revenue 2002-03

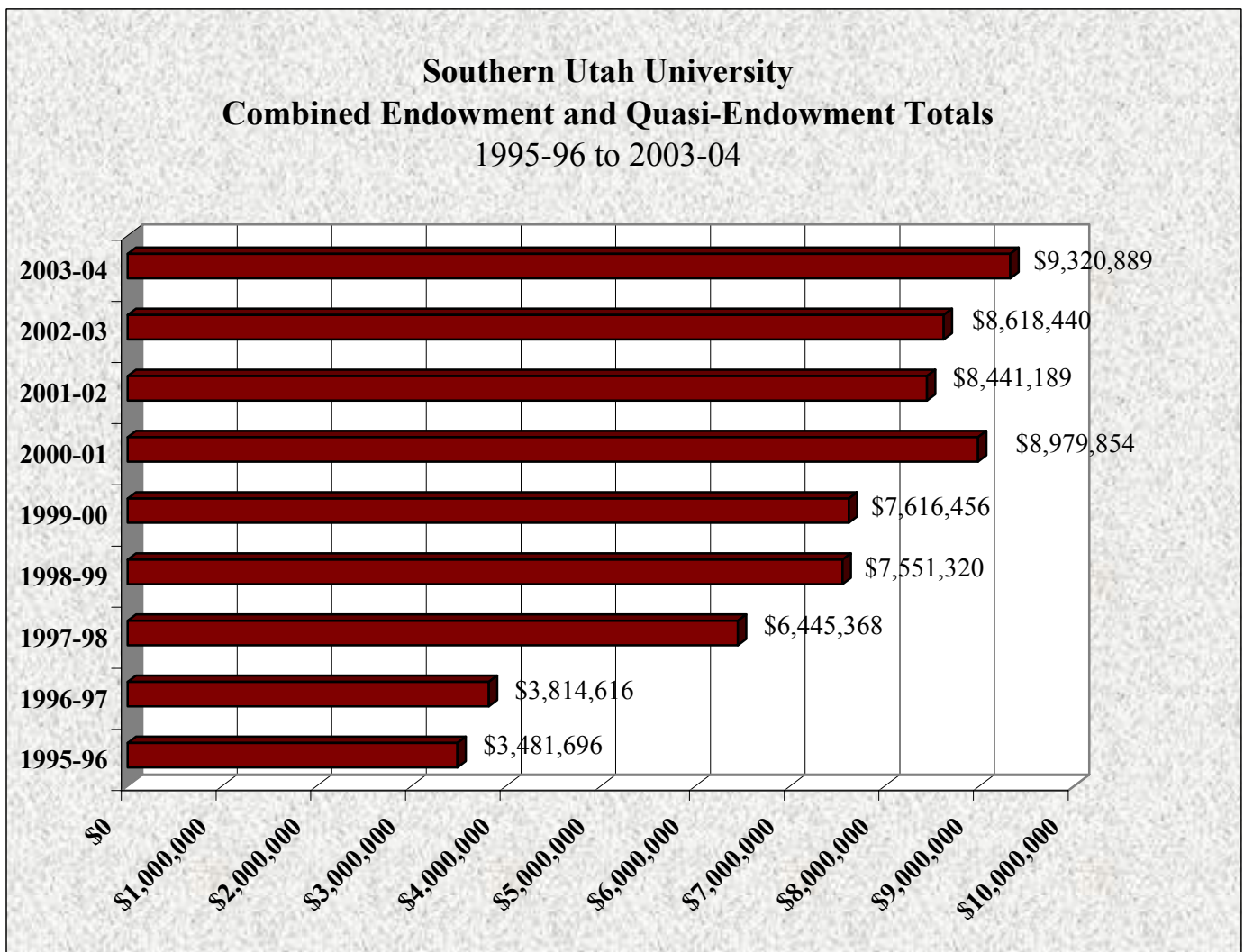
