

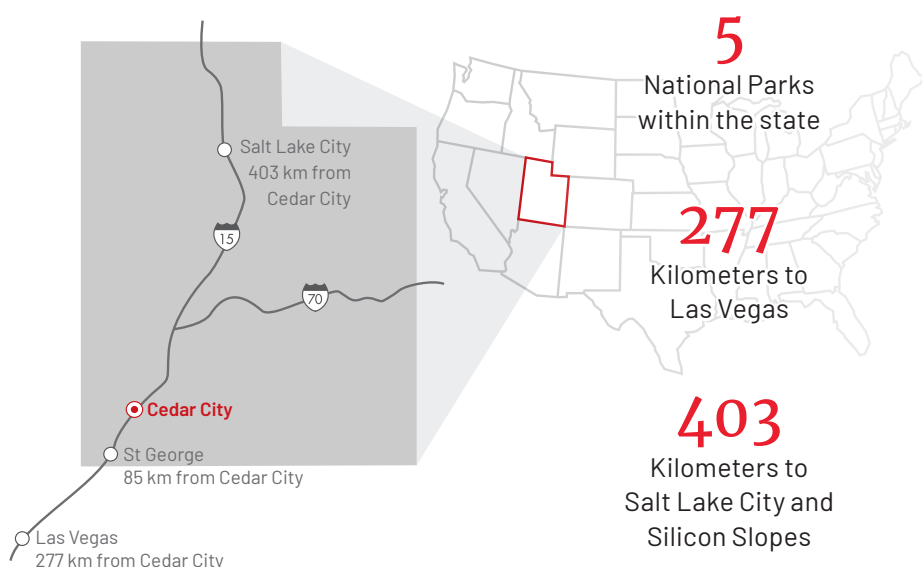

## HOW TO APPLY FOR INTERNATIONAL GRADUATE ADMISSION

Apply at [www.suu.edu/apply](http://www.suu.edu/apply) and provide the following International Admission Requirements in addition to program-specific Admission Requirements listed below each program.

1. International college transcripts must be evaluated by an authorized evaluation company. SUU's preferred evaluation company is SpanTran.
2. Along with all International Admissions Requirements you will need to pay a \$60 Application Fee and satisfy all individual graduate program admission requirements
3. Proof of English Proficiency: TOEFL ibt (79) OR TOEFL ESSENTIALS (8.0) OR IELTS (6.0), Duolingo (105) OR Completion of Southern Utah University Intensive English Program
4. Financial statement form AND bank statement for two academic semesters
5. Copy of photo page of passport

## MASTER OF SCIENCE IN BUSINESS ANALYTICS (MSBA)

TOTAL ESTIMATED ANNUAL COST: \$26,726

The Master of Business Analytics program at SUU trains students to use data, statistical analysis, and mathematical models to solve business problems, improve business processes, and make better business decisions. The program aims to achieve the optimal balance between technical expertise and real-world applications, to produce graduates who can apply appropriate methodologies in practical ways.

### ADMISSION REQUIREMENTS

1. Official transcripts from each college or university attended AND diploma
2. Contact information for 3 professional references
3. Official GRE or GMAT scores attained within the last 5 years, unless the conditions are a met for a test waiver.
4. Professional resume
5. Letter of intent

## MASTER OF FINE ARTS IN ARTS ADMINISTRATION (MFA)

TOTAL ESTIMATED ANNUAL COST: \$26,442 | DEADLINE: MARCH 1st

The Master of Fine Arts in Arts Administration develops graduates who can balance administrative systems and creative processes to ensure the economic stability and artistic integrity of arts organizations. Coursework totals 60 credit hours.

### ADMISSION REQUIREMENTS

1. Bachelor's degree in an artistic or business-related field from an accredited university, demonstrated by an official transcript, with a 3.0 GPA or higher
2. Letter of Intent
3. Resume including academic, professional, and volunteer experience
4. Letters of three professional references including contact information

## MASTER OF EDUCATION (MED)

TOTAL ESTIMATED ANNUAL COST: \$22,846

The Master of Education prepares educators to become master teachers in their profession in the Education field. Coursework totals 33 hours.

### ADMISSION REQUIREMENTS

1. Official transcripts
2. 3.0 GPA
3. Recommendation from an immediate supervisor
4. Teaching in some capacity
5. Orientation

## MASTER OF ATHLETIC TRAINING (MAT)

TOTAL ESTIMATED ANNUAL COST: \$24,472

Southern Utah University's athletic training program is accredited by the Commission on Accreditation of Athletic Training Education (CAATE). The program is unique because it gives students the opportunity to work closely with NCAA Division I college athletes, local high school sports teams, and chiropractors and physicians from throughout the southern Utah region.

### ADMISSION REQUIREMENTS

1. A completed bachelor's degree with a Minimum undergraduate GPA of 2.5 and grade of "C" or better in all prerequisite courses (coursework must be within 10 years of application)
3. GRE scores. Students that have a GPA of 3.0 and above are exempt from taking the GRE
4. Letter of Application to the Master of Athletic Training Program
5. Two (2) letters of recommendation (one from a college-level instructor and one from a currently practicing certified athletic trainer)
6. Program interview (on-campus or via video conference)
7. Official transcripts from all colleges/universities attended
8. Documentation of at least 50 hours of observation with a Certified Athletic Trainer(s)

## MASTER OF ACCOUNTANCY (MAcc)

TOTAL ESTIMATED ANNUAL COST: \$26,726

The Master of Accountancy program provides greater breadth and depth to further develop the knowledge and skills needed to enter professional accountancy. With nearly a 100 percent placement rate, MACC graduates have opportunities to work for accounting firms or government agencies across the U.S. and around the world. Typical jobs include positions in taxation, auditing, and controller-ship.

### ADMISSION REQUIREMENTS

1. You must have graduated in accounting from an AACSB accredited school or there will be foundation courses required.
2. Bachelor's degree from an accredited university, demonstrated by an official transcript, with a 3.0 GPA or higher. Course syllabi of required foundation courses
3. Acceptance to the program requires an Admission Index Score of 1400. Index=(GPA X 200)+(GMAT X 1.5) GRE scores are converted to a GMAT equivalent.
4. Students from AACSB accredited schools may be eligible for a GMAT/GRE waiver based on GPA or work experience
5. Contact info of 3 people for references
6. Resume

## MASTER OF BUSINESS ADMINISTRATION (MBA)

TOTAL ESTIMATED ANNUAL COST: \$26,726

SUU's MBA program is AACSB accredited and designed to create business leaders. Students will be instructed by professors with real-world experience dedicated to fostering their professional development. This unique approach has placed SUU's MBA program in the Top 100 in the nation, according to U.S. News & World Report.

### ADMISSION REQUIREMENTS

1. Bachelor's degree from an accredited university, demonstrated by an official transcript, with a 3.3 GPA or higher  
Official GMAT or GRE test score requirement may be waived for applicants who demonstrate sufficient academic achievement (at least a minimum GPA of 3.3) or who have significant managerial or professional experience (generally at least 3-7 years).

3. Professional Resume including managerial experience
4. A list of three professional references including contact information

## MASTER OF INTERDISCIPLINARY STUDIES (MIS)

TOTAL ESTIMATED ANNUAL COST: \$26,442

SUU's Master of Interdisciplinary Studies degree provides an opportunity for students to build a graduate degree from three disciplines, resulting in a unique interdisciplinary experience. Since this 30-credit degree allows you to develop an individualized program of study, you can tailor it to your personal passions and career objectives. You will enjoy the flexibility of online and/or face-to-face courses, taught by highly-qualified faculty.

### ADMISSION REQUIREMENTS

1. Bachelor's degree from an accredited university, demonstrated by an official transcript, with a 3.0 GPA or higher in last 60 credits.
2. Answer the Statement of Purpose questions on the application
3. Resume
4. A list of three professional references including contact information
