Southern Utah University Updated List of Peer Institutions (Spring 2024)

In compliance with NWCCU's Standards 1.D.2 and 1.D.3, and in response to a request from the Utah System of Higher Education (USHE) to update SUU's list of peer institutions in accordance with <u>R508</u>, SUU engaged in a process to identify an updated list of 12 peer institutions in April 2024. After a careful review of IPEDS data, the following list of 12 peer institutions has been identified:

- 1. Central Washington University (WA) *
- 2. Fort Hays State University (KS)
- 3. Kutztown University of Pennsylvania (PA)
- 4. Murray State University (KY)
- 5. Northwest Missouri State University (MO)
- 6. Southeast Missouri State University (MO)
- 7. State University of New York at Oswego (NY)
- 8. SUNY Brockport (NY)
- 9. University of Nebraska at Kearney (NE)
- 10. University of Wisconsin-Eau Claire (WI)
- 11. University of Wisconsin-Whitewater (WI)
- 12. Weber State University (UT) *

Institutions with * are considered regional peer comparators because they are also accredited by NWCCU. The selection process leading to this updated list of peer institutions followed these steps:

Step 1: Cast a Wide Net

Identify a broad group of institutions using IPEDS categories, including: Sector (Public, 4-Year or Above), Degree-Granting Status (Degree-Granting), Highest Degree Offered (Master's Degree; Doctor's Degree - Professional Practice), Institutional Category (Degree-Granting, Primarily Baccalaureate or Above), and Institutional Size Category (5,000-9,000 and 10,000-19,999). Several other IPEDS categories were also used (Admissions Policy, First-Time Full-Time Undergraduates, Carnegie Classification, and Degree of Urbanization / Locale). In addition, the following regional institutions in USHE were included: Utah Tech University, Utah Valley University, and Weber State University. All other USHE institutions were also included during this step. As a result, a total of 47 institutions (including SUU) were included in this preliminary group.

Step 2: Comparisons & Analysis

Systematic comparisons were then completed using 40 different IPEDS criteria. For example, comparisons were conducted according to such factors as: undergraduate and graduate enrollment, cost of attendance, graduation and retention rates, student-to-faculty ratio, degrees awarded, amount of state support, instructional and academic support expenses (as a percentage of total core expenses), and average faculty salary.

Through a series of calculations and a robust analysis across these 40 criteria, a group of 17 institutions was identified based on each institution's overall similarity to SUU. Those 17 institutions were then rank-ordered in terms of similarity to SUU.

Step 3: Final List of 12 Peer Institutions

Based on the rank-ordered list of 17 institutions, SUU identified the top 12 institutions as its list of peer institutions. A complete spreadsheet is also available that includes a full account of IPEDS data, peer institutions, and calculations.
