**SUBJECT: DEANS' COUNCIL**

---

- I. **PURPOSE:** To coordinate and recommend all aspects of the academic budgets, calendar, class schedules, curriculum, planning, and other policies related to academic affairs.
- II. **POLICY:**
  - A. The Council serves as the representative agency at the University level for specific policy matters relating to faculty concerns that are more restricted to departmental or college, line-authority issues. For more general policy matters relating to faculty concerns which have University-wide ramifications, the Deans' Council and the Faculty Senate constitute the two academic bodies who recommend general academic policy to the University Provost.
  - B. The Deans' Council consists of the following voting members: Academic Deans, Executive Director of the School of Continuing and Professional Studies and non-voting members from the administration as well as the SUUSA student Academic Vice President. See the "Attachment to 13.9" for the list of the non-voting ex-officio members of Deans' Council
  - C. The Deans' Council meets every two weeks or more often as necessary during the academic year, and every month during Summer School. Other meetings are called on an ad hoc basis as needed.
  - D. Deans' Council receives recommendations, reviews, acts upon and monitors the functions of the Undergraduate and Graduate Curriculum Committees.
  - E. The Deans' Council is directly responsible to the Provost who functions as its chair.
