



SB #23/24-06: Lacrosse Club Funding Request

Be it enacted by the SUUSA Student Senate assembled:

1. *Section 1: Purpose.*
 - a. The purpose of this legislation is to provide funding to the SUU Men's Lacrosse Club from the SUU Clubs Budget in accordance with the provisions of the SUUSA Funding Policy (which requires a 2/3rd vote to provide such funding in such a manner) for the purpose of funding Men's Lacrosse Club with funds needed for the participation in the Las Vegas MCLA Tournament.
2. *Section 2: The Senate finds:*
 - a. In accordance with the mission of SUUSA and its associated ends, funding is an important part of the process by which students are enabled to participate in events, activities, and other opportunities for growth, development, and involvement.
 - b. The SUU Men's Lacrosse Club, having received \$1250 from the Budget and Finance Committee after submitting a request for funding to subsidize registration fees to enter the Las Vegas MCLA Tournament,

ought to have access to such funding despite the imposition of a new policy barring requests or granting of money from requests of such a nature.

3. *Section 3: Action 1:*

- a. In accordance with provisions of Article IX of the SUUSA Funding Policy, \$1250 from the SUUSA Clubs budget shall be allocated to the SUU Men's Lacrosse Club to subsidize costs linked to registration to the Las Vegas MCLA Tournament and associated costs pertaining to participation in said tournament.
- b. Said funding actions will be carried out by Vice President of Clubs Gabby Garcia in conjunction with Vice President of Finance William Harrison as soon as practically possible.
- c. The funding provided herein shall only be used by the SUU Men's Lacrosse Club for the above expressly stated purposes.
- d. In the event that the SUU Men's Lacrosse Club is unable or unwilling to attend the Las Vegas MCLA Tournament, the funding herein shall be withdrawn to the extent that it has not been used by the SUU Men's Lacrosse Club. The SUU Men's Lacrosse Club will (in good faith) exhaust every means to recover any funds spent in connection with the planned participation in the Las Vegas MCLA Tournament in the event of non-participation in said tournament.

4. *Section 4: Action 2:*

- a. The Men's Lacrosse Club will report to Vice President Gabby Garcia with results from the tournament.
- b. The Men's Lacrosse Club will report to the SUUSA Senate with the same results from the tournament.

5. *Section 6:* This legislation shall take effect immediately.
