**SUU Aviation Program Addendum**

1. \_\_\_\_\_ I understand that the VA will only pay for aviation courses while in pursuit of an Aviation degree from SUU. As such, there must always be at least two non-flight lab courses taken in conjunction with aviation flight lab courses or until all non-flight lab courses within the degree have been completed. This requirement may only be waived by the Veterans' Resource and Support Center.
2. \_\_\_\_\_ I understand that I have 30 calendar days to meet with my Advisor and register for classes after initial enrollment starts. If within 30 days there are no spaces available for non-aviation classes, certification shall be approved. In the event that 30 days has elapsed and I have not made the necessary efforts to secure degree works approved non-aviation classes, certifications shall be deemed null and void and the student will be unable to utilize G.I. Bill benefits for flight related courses.
3. \_\_\_\_\_ In addition to the above, I further understand that If I do not receive at least one passing grade in a non-aviation course in a semester, I may be held liable for any and all monies paid to the school from the VA, in addition to having my housing allowance, and book stipends recouped as well.
4. \_\_\_\_\_ I understand that once I have completed Private pilot certification lab, I will be unable to switch flight platforms until I have completed all requirements for the AAS in the respective emphasis.
5. \_\_\_\_\_ I understand that I will be unable to certify for any flight lab while still under an extension of another flight lab.
6. \_\_\_\_\_ The student is responsible for completing Math and English General Education requirements within 60 SUU credits, or future certifications will not processed to the VA. Flight labs will not be certified if Math or English are not completed by the specified credits.
7. \_\_\_\_\_ I understand that I may not be granted an extension or incomplete grade unless the following conditions have been met:
  - a. There has been a significant mitigating circumstance identified as cause for the incomplete grade.
  - b. I have met with my advisor and a plan has been developed to ensure the required coursework/hours will be completed in a timely manner.
  - c. I have notified the Veterans Resource and Support Center and will continue to keep them updated on my completion status.
8. \_\_\_\_\_ I Understand that if I am placed on Academic Probation for a period of more than two academic terms with an overall G.P.A. under a 2.0, that I will be unable to register for any flight program classes, or labs.
9. \_\_\_\_\_ I understand that if taking a flight lab, I am required to have at least twice as many hours open for scheduling flight times as the lab requires. I.E. A RW lab that requires 40 hours of flight

instruction time, will require 80-hours of availability from the student. This will ensure that all students will be able to finish their required flight hours within the given time period.

10. \_\_\_\_\_ I understand, it is my responsibility to notify the Veterans' Resource and Support Center in the event that myself or my instructor is late or cancels one of my scheduled flight times without prior notice and without making arrangements to reschedule within a timely manner.
11. \_\_\_\_\_ I understand that if, at any time I have an issue or problem with any lab or class, it is my responsibility to bring it to the attention of The Veterans' Resource and Support Center.

The student acknowledges they have reviewed, understand and will comply with the expectations and requirements as outlined above. Any violation of this outline can result in the transfer of debt to the student being held liable for any and all monies paid to the school from the VA, in addition to having my housing allowance, and book stipends recouped as well.
